Re: Executive Summary & Analysis: Results of Pre-Test Survey in Washington, DC

Introduction & Methodology

the polling companyTM, inc./WomanTrend is pleased to present to the Center for Education Reform (CER) this analysis of findings from a recent telephone survey of 250 adult (18+) residents of Washington, DC.

The survey was fielded July 7-9, 2006 at a Computer-Assisted Telephone Interviewing (CATI) facility using live callers. The sample was drawn utilizing a Random Digit Dialing (RDD) method where phone numbers were generated by a computer to ensure that every household in the District had an equal chance to be surveyed.

Sampling controls were used to ensure that a proportional and representative number of people were interviewed from such demographic groups as age, gender, race and ethnicity, and Ward. All interviewees had the option of having the survey administered in either English or Spanish¹.

The survey was ten questions in length including six demographic inquiries and one open-ended question. The final questionnaire was approved by the President of CER prior to fielding. Topline results are attached as Appendix A to this report.

This "pre-test" survey was conducted in advance of a communications and outreach program planned by CER. The primary objective of the survey was to measure awareness and knowledge of the *DC Opportunity Scholarship Program* and the transfer options available to DC public school students by utilizing vouchers. Upon conclusion of the outreach effort, scheduled to run from July 2006 to March 2007, a "post-test" survey will be conducted to measure the impact of the campaign on residents' awareness of and support for the program.

The margin of error is calculated at \pm 6.2% at the 95% confidence level, meaning that the results obtained would differ by no more than 6.2 percentage points in either direction if the entire adult population of the District of Columbia were to be surveyed. Margins of error for subgroups are higher.

Analysis of Findings

<u>ROOM TO MOVE</u>: Only 11% of DC Residents Acknowledged Familiarity with the DC Opportunity Scholarship Program in the Baseline Test.

Washington, DC residents lack a fundamental knowledge about the DC Opportunity Scholarship Program. Overall, just one-in-ten (11%) of those surveyed were aware of the Program, and a paltry 2% claimed to be "very familiar" with it.

By comparison, 78% admitted they did not recognize the Program. In fact, an eyepopping 68% of residents claimed a complete lack of knowledge, noting they were "very unfamiliar."

To begin, how familiar are you with the DC Opportunity Scholarship Program, administered by the Washington Scholarship Fund?

- An examination of the crosstabs revealed that among the demographic groups studied, 35-54 year olds were most likely than respondents overall to be familiar with the Program (17%-11%).

This full-disclosure of ignorance by DC residents is even more remarkable given that people are often hesitant to reveal that they are "out of the loop." The fact that respondents so willingly acknowledged that they were wholly unacquainted with the DC Opportunity Scholarship suggests that the District is a true blank slate on which a compelling message can be written.

This nearly complete lack of awareness presents a challenge (starting at zero), but mostly an opportunity for CER. Rather than battling pre-conceived notions, stereotypes or misinformation, CER will be able to build an understanding of the Scholarship Program among residents "from the ground up."

Even Those Who Think They Know about the DC Opportunity Scholarship Program Lack Specific Information about its True Intent.

Respondents who reported some level of knowledge with the Opportunity Scholarship Program² were then asked in open-ended fashion to describe it in their own words. **Despite their self-reported familiarity with the DC Program, only a handful of these residents were able to accurately explain it.**

Four-in-ten (40%) could not or would not elaborate on the Scholarship, saying simply that they did not know, while 25% thought it provided funds for DC students to go to college. Another 15% volunteered that the program provided some kind of financial assistance for schooling, but without clarification as to who was eligible or to what schools they scholarship monies were provided.

² Only respondents who said they were "very familiar," "somewhat familiar," or "somewhat unfamiliar" with the DC Opportunity Scholarship program in question 1 were asked this follow-up inquiry (N=52).

In total, only 7 of the 250 residents surveyed correctly described the DC

Opportunity Scholarship Program as a voucher program to send public school

students to private schools. Among them, three shared a neutral account, two offered a positive assessment, and two made their disapproval of the Scholarship plain.

SELECTED VERBATIM RESPONSES OF DC RESIDENTS WHO ACCURATELY EXPLAINED THE DC OPPORTUNITY SCHOLARSHIP PROGRAM:

POSITIVE

"They go by according by the parent's income and once you are approved then you receive a handbook of choices of schools from K-12 grade and they help pay for everything and it was a blessing and they also give me a weekly report card of my child's progress. I strongly approve of this program."

"Very good idea. Opportunity for students enrolled in public schools not working up to par to have an opportunity otherwise unavailable, by paying private school expenses."

NEGATIVE

"It takes tax payers' money and gives it to private schools rather than give it to public schools for improvements. It undermines the public school and it allows private people running charter schools to profit of off the publics money and steal it."

"A support system for low income people to go to private schools (K-12) and I must say I am totally against the program because it infringe on the public school system."

NEUTRAL

"It's essentially the voucher program. The money that goes to DC children to pay for private school, often called vouchers."


"It's scholarships for students in low performing schools to allow them to attend private schools with limited amount of money."

"Is provided by the federal government provided to families at 185% poverty level for their children to go to private school."

The Majority of Residents Don't Even Venture a Guess as to What the DC Opportunity Scholarship Provides.

The fundamental misunderstanding of the Opportunity Scholarship Program revealed in responses to the open-ended inquiry was reinforced and quantified by the findings from the next question – a closed-ended query which asked all respondents to select what the Scholarship provided from a list of four read answer choices.

A majority of residents (56%) freely admitted that they did not know what the DC Scholarship granted, even when given a list of possibilities from which to choose.



<u>Program provided "money for DC students to attend private schools."</u> The most common conclusion drawn by respondents was that it offered "college scholarships for DC students" (23%), while single-digits selected "sponsorships for DC students to travel abroad as exchange students" (5%) and "money for DC students to attend summer school programs" (3%).


- Residents aged 55 or older and those who reported that they were at least somewhat familiar with the Scholarship Program at the outset of the survey were more likely than most to know that it helped students afford private school.
- Not a single respondent who identified themselves as Hispanic or Latino thought the DC Opportunity Program provided money for private school.

A Simple Explanation of the DC Opportunity Scholarship Program Nets a Favorable-to-Unfavorable Ratio of 4-to-1.

Education is a common path to engagement and acceptance. An impressive 64% of DC residents responded positively to a straightforward, factual explanation of the DC Opportunity Scholarship Program. The intensity of residents' embrace of the Scholarship Program was notable, with 42% reporting a "strongly" favorable opinion, nearly double the 22% who held a "somewhat" positive view.

By comparison, 15% of DC residents met the description of the Opportunity Scholarship with a "thumbs down."

One-in-ten (11%) claimed neither a favorable nor unfavorable opinion of the Program based on the description, and another 8% said they did not know. Combined, this suggests that almost one-in-five DC residents currently on the fence about the DC Opportunity Scholarship Program may be



"gettable" if targeted with additional information.

- Blacks stood out among the demographic cohorts studied as among the most supportive of the Opportunity Scholarship Program (70% "favorable").
- Men were more likely than women to have a positive opinion of the Program (68%-61%).

- Whites and 35-54 year olds were more apt than respondents overall to have an
 unfavorable view of the DC Program, though clear majorities of both groups
 offered a positive assessment.
- Hispanics and those without children at home emerged as the groups most likely to volunteer a neutral opinion of the Opportunity Scholarship.

It appears that the simple facts about the DC Opportunity Scholarship Program are enough to generate significant support. CER may find the greatest success by sticking to the basics and increasing understanding and acceptance of the Program with simple yet specific information that includes both "hard facts" (statistics about what is provided and who is helped) and "soft anecdotes" (testimonials from parents and children who have benefited).
