Notes of Decisions

Curriculum

There was substantial evidence to support the school board's conclusion that the school district's failure to offer Industrial Arts classes to grades 9-12 during the 1993-94 school year was the result of no one enrolling rather than a failure to offer the course. Thus, there was no improper elimination of educational programs or altering of courses and the teachers failed to meet their burden of establishing that one of them was impermissibly suspended when the elementary school was consolidated with the middle and high schools. *Bricillo v. Duquesne City Sch. Dist.*, 668 A.2d 629 (Pa. Cmwlth. 1995).
