significantly in rank, either because they strengthened charter school laws considerably since 2022 or made changes within law that expanded charter numbers, freedom or funding. Eight states dropped significantly in the rankings.

Overall, state rank and charter policy environments are improving, particularly in states that have tended to embrace education freedom in general.

In 2022, only 8 states earned a "B" grade. In 2024, 13 states hold a "B." Two states - Alaska and Iowa - moved out of the "F" ranking.
